In applying for consideration to officiate at Unionville Milliken Soccer Club (UMSC) outdoor house league games, if offered refereeing engagements from time to time, I will fulfill the following duties, completion of which is a condition of payment in full of my fee: I will ensure that I have paid my annual fee and that I am properly registered with the York Region Soccer Referee Association. I will take direction from the Head Referee, Vice President House League or their designate regarding the time and location of my appointments. I will provide a phone number and e-mail address for the purpose of communications regarding appointments. **If a change in my appointment is required, I will advise the UMSC DIRECTLY by phone, NOT VOICEMAIL, or by e-mail a day in advance so that a change may be made through the UMSC office.** I will attend my appointments on time in uniform acceptable to the Vice President, House League or their designate, with stopwatch, whistle, referee patch, notebook and pencil so that I may fulfill my duties properly and I shall do so to the best of my ability. I will obtain a game sheet from team official, and check the sheet to ensure that it is signed, dated, and the score and scoring players are marked correctly. I will return the game sheet and report the score promptly after the game, in the manner directed as required to the Office. I will not argue with coaches or players, but I will report misconduct by coaches or players on the game sheet. I will be courteous and professional with coaches and players, giving coaches the respect due volunteers and fellow professionals. **ENSURE YOUR NAME APPEARS ON THE GAME SHEET FOR PAYMENT – NO PAYMENT UNLESS YOU ARE LISTED**

## Release and Waiver

The undersigned acknowledges that the applicant herein is not an employee of the Unionville Milliken Soccer Club, but may be called on a contract basis, from weekend to weekend, as required for the operation of the indoor house league. The undersigned acknowledge that refereeing soccer is a risky activity, but in consideration of the acceptance of the applicant for opportunity to perform referee duties at the Unionville Milliken Soccer Club, the undersigned releases the Unionville Milliken Soccer Club, its directors, officers, employees, members and volunteers, from any liability for personal injury to the applicant, or loss or damage to the applicant's property or property in the applicant's care which may be sustained during the course of carrying out referee duties or attendance in the facilities of the Unionville Milliken Soccer Club.
